## **About Our Program**

TD Bank welcomes the opportunity to consider applications for sponsorship from a wide range of for-profit and not-for-profit organizations that meet our criteria and are of mutual benefit to our communities and the bank.

#### As a sponsor of an initiative, TD Bank expects to achieve the following goals:

- ✓ Create an <u>Unexpectedly Human</u> impression of the bank
- Provide participation and business opportunities for bank colleagues
- Enhance relationships with community organizations through networking opportunities
- Generate qualified leads that result in new business
- Support the community in a positive way

#### The following would not be considered for funding:

- Organizations that discriminate on the basis of race, national or ethnic origin, color, religion, age, sex, sexual orientation, gender identity or expression, marital status, family status, veteran status, disability or other characteristic protected by law
- Organizations or events which are not open to members of the general public
- Annual appeals and general operating support
- Political candidates, lobbying or advocacy organizations
- Organizations with a limited constituency, such as fraternal, civic or labor groups
- Religious organizations, unless the program supports and is open to the community
- Individuals and families
- Trips and tours by groups or individuals
- Golf outings and tournaments
- Scholarships drives
- Membership fees or dues
- Research projects



## **Before You Apply**

- Organizations must apply online for event/program funding and supply all required documentation as listed below. <u>Online Application Portal</u>
- ✓ Applications for events or programs must be submitted at least 90 days before your earliest print deadline.

✓ Applications are reviewed twelve (12) times per year. Please refer to the timelines below to plan your application. The online application portal is open all year, however applications will only be reviewed during the timelines noted. If you miss an application deadline, your application will be automatically pushed to the following round so you don't need to reapply.

## **Payment Requirements**

If your event/program is preliminarily approved for funding, the following criteria must be met before your application can move to the official approval/payment cycle in our system.

Attest to TD Bank Terms & Conditions Agreement ("TCA") through the online application

Approved applications may require a Certificate of Insurance ("COI") as outlined in the TCA information below. While applicants will receive *conditional* approval via e-mail, payment processing will not begin until the appropriate COI is received.

- Minimum of \$1,000,000 in Liability Coverage
- ✓ List TD Bank, N.A. as an additional insured
- ✓ The Certificate Holder section must read: "TD Bank, N.A., 12000 Horizon Way, Mt. Laurel, NJ 08054"
- In the event alcohol is served or provisioned at the sponsored event, the coverage must include Liquor Liability (if the applicant is providing and serving the alcohol) or Host Liquor Liability (if the applicant has hired a professional alcohol server to do so).

## **Frequently Asked Questions**

#### If I am interested in obtaining sponsorship funding, must I use the online application?

Yes. The online application can be completed in 30 minutes or less.

#### How will I know my sponsorship request has been received?

After submission, you will receive an email at the provided address with confirmation.

Note: You will also receive a confirmation for a saved application. Please ensure you make the appropriate selection and submit the application once you're ready for consideration.

#### Who will review my application and make the final funding decision?

Applications are reviewed by your local TD Bank Community Sponsorship team.

#### May I advocate my proposal in-person or by phone?

Unfortunately, due to the high volume of requests, individual meetings with applicants are not possible.
